# 11.0 Chief of Police Reports

# 11.1 2025-030: Human Resources Dashboard 2024 Annual Report

M. Kimpel presented report 2025-030 for information, providing an overview of Human Resources data with respect to Health and Safety, Wellness, Overall Staffing Levels, Occupational and Non-Occupational Absences, Recruitment and Resignation/Retirement turnover for 2024.

Vice Chair Redman acknowledged the volume of follow up calls to check on wellness as a proactive way of making members feel included. M. Kimpel noted that in many ways, WRPS is leading in this programming.

# 11.2 2025-027: Strategic Business Plan 2024-2027 Progress Report #2

A. Franceschini presented report 2025-027 for information, providing general planning and specific progress updates.

Vice Chair Redman noted that the shift from quantity to quality in the reporting provides a valuable context.

# 11.3 2025-048: 2024 Chief and Public Complaints Statistics

Inspector Lewis presented report 2025-048 for information. Last year, with an authorized complement of 848 sworn officers, WRPS received 346,014 calls for service, 100 thank you letters (approximately) and 47 screened in

public complaints.

K. Quigley-Hobbs recognized the professional approach utilized for complaints, and how the service uses these to improve and learn.

# 11.4. 2025-047: Road Safety Plan

Staff Sergeant Griffiths presented report 2025-047 for information. The primary objective of the Traffic Services Unit is to reduce major injury collisions and fatalities by strategically targeting key issues causing them.

S. Shantz asked for clarity on WRPS' partnerships with the Region and Townships to set appropriate speed limits. Staff Sergeant Griffiths explained that this unit attends Traffic Coordinators meetings, as well as offering advice to the Region when requested.

Vice Chair Redman asked about Black Cat Technology. Staff Sergeant Griffiths explained that this is a traffic survey device that can be mounted on a pole to anonymously analyze vehicle traffic.

# 11.5 2025-028: Regulated Interactions Annual Report

H. Siddiqui presented report 2025-028 for information. Regulated Interactions were most likely to involve individuals who were: between 19 – 29 years of age, male, and White. Black, Middle Eastern, and South Asians were overrepresented in Regulated Interactions, compared to the local resident population.

H. Siddiqui and M. Williams noted that we're seeing more data that can provide insight into year over year trends. This data can help to inform systems reviews at WRPS, including policy.

# 11.7 2025-050: Community Safety and Well Being Plan: Police Re-Contact

Inspector Mathias presented report 2025-050 for information, examining 2024 re-contact data related to mental health calls for service, youth victims of crime and youth who are proximate to incidents of intimate partner violence, using the lens of adverse childhood experiences.

Chief Crowell highlighted a recent Media Roundtable on February 10, 2025. Four males were arrested after a recent Drug Investigation in Cambridge; charges were laid in gift card scam investigation. The 2025 Polar Plunge is scheduled for March 1, 2025 in support of the Special Olympics.
